The **TATA Chair on Information Technology at IEG** has been set up to promote research and higher levels of learning in Information and Communication Technology, Information Economics, Industrial Organisation, Productivity, Government Policy & Regulation, Service Sector Growth and other related fields. Besides conducting research at the highest level on any of the focus areas of the Chair, the appointee will contribute to wider activities of the Institute, in terms of training, teaching, and sponsored research.

The essential qualification and all other details for the respective post are given below: -

**1. Professor - TATA Chair on Information Technology**

Essential Qualifications

Eligibility (A or B)

**A.** (i) An eminent scholar having a Ph.D. degree in Economics or Finance and published work of high quality, actively engaged in research and policy with evidence of published work, with a minimum of 10 very good research publications in the peer-reviewed or UGC-listed journals and a total research score of 120 as per the criteria given in Appendix-II, Table 2 (enclosed).

(ii) A minimum of ten years of teaching experience in university/college as Assistant Professor/Associate Professor and/or research experience at an equivalent level at University/National Level Institutions with evidence of having guided doctoral candidates.

Or

**B.** An outstanding professional, having a Ph.D. degree in Economics or Finance from any academic institution (not included in A above)/industry, who has significant publications and has made contributions to the field of Economics/Finance supported by documentary evidence provided he/she has ten years experience.

**Age:** Below 45 years (relaxable in Deserving Cases).

### **Desirable Qualifications**

- a. Demonstrable experience in successfully collaborating and/or leading research and or evidence-based policy analysis as part of a research project or programme.
- b. National and International experience in partnering with Government Institutions and/or Multilateral Institutions.
- c. Candidates' work should be in the areas of: Information and Communication Technology, Information Economics, Industrial Organisation, Productivity, Government Policy & Regulation, Service Sector Growth and other related fields.

### **General Instructions for Candidates**

1. The application has to be filled out online on the Institute's website i.e. [www.iegindia.org](http://www.iegindia.org) under the "Career" web link along with the instant advertisement. The application is to be submitted by **May 10, 2023**.
2. After submission of the online application, applicants are required to download the filled-up application form and send it along with self-attested educational qualification certificates and testimonials (hard copy). Also require to send the names of three references and copies of the ten best publications by post.

On the top of the envelope, write "Application for the Post of Professor/Assistant Professor, TATA Chair on Information Technology addressed to the Director, Institute of Economic Growth, University of Delhi Enclave, North Campus, Delhi-110007. The hard copy of the application should reach by **May 22, 2023**.

3. Those who have applied for any of the above post in response to this Institute's advertisement published in Economic & Political Weekly in the November 12, 2022 issue and interested to consider as per qualifications mentioned in the above advertisement, need to inform the Institute through email/letter about the interest to consider his/her application.
4. Candidates working in Government/Autonomous Bodies/Universities/ Institutions of repute must send the hard copy of the application through the proper channel. The salary of the candidate working in the pay scale will be protected if selected.
5. Persons of Indian Origin (PIO) or Overseas Citizens of India (OCI), if selected, the appointment will be on contract for up to three years subject to clearance from the Govt. of India before he/she can join the Institute. Extension beyond three years will be subject to a review process and necessary approvals.
6. Applications which do not meet the criteria given in this advertisement and/or incomplete applications are liable to be summarily rejected.
7. Consequent to the adoption of self-certification provisions as required by the Government of India, the Institute shall process the applications entirely on the basis of information/documents submitted by the candidates duly self-attested. In case the information/documents are found to be false/incorrect by way of omission or commission, the responsibility and liability shall be the sole responsibility of the candidate.

8. Candidates called for physical interview should report along with all the testimonials/certificates in original along with photo ID as per eligibility conditions.
9. Candidates should possess the prescribed qualification and experience as of the closing date of application.
10. Further, merely fulfilling the minimum qualifications or the eligibility criteria does not entitle a candidate to be necessarily considered or called for an interview. More stringent criteria may be applied for short-listing the candidates to be called for an interview.
