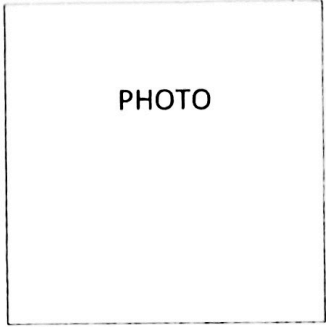

TERMS & CONDITION

1. **Duration of Contract** :- The engagement shall be purely on contract basis for a period of six months only/OR till joining of regular candidates through DSSSB OR through promotion, whichever is earlier. The service of the contractual officer shall stand automatically terminated at the expiry of the contract period, unless terminated earlier, without giving any notice to the contractual officer and without any liability on the part of the LNH to pay any remuneration or other compensation or any other amount to the contractual official. The contract may also be on satisfactory service performance, provided extension for a considered period and may be terminated without assigning any reason before expiry of the contract period.
2. **Full time engagement**:- This engagement will be on full time basis and the contractual officer shall not take up any other activity or work or hold any position elsewhere which may hamper his/her duty as assigned hitherto as may be prejudicial to the interests of the Government.
3. **Non-Disclosure of Information**:- The contractual officer undertakes not to disclose/divulge or make public aspect on legal obligations, any information that he/she may acquire in course of his/her work without the written consent of LNH authorities.
4. **No claim for regularization in the Govt.**:- The contractual officer shall have no right or claim or preference either for regular employment in LNH or for regular employment in any Govt. Job or for regularization or for extension of the period of the contract on account of his/her engagement on contract basis and the contractual officer undertakes not to make any such claim at any point of time. The contractual officer shall not claim any right to be treated as a Govt. Servant or be absorbed in Govt. Service at any future point of time.
5. **Termination of Contract**:- The LNH reserves the right to terminate the contractual agreement at any point of time if it is found the services rendered by the contractual officer is not satisfactory or if it found at any declaration of information furnished by him/her proves to be false or willfully suppressed or if there is any breach of any of the terms & conditions of this term of contractual engagement or if the contractual officer is found to be involved in any act of indiscipline or misconduct. The contract may be terminated forthwith without any notice. The decision of LNH in this regard shall be final and binding on the contractual officer and shall not be subject to challenge.
6. **Not to sign on behalf of LNH.** The contractual officer is not authorized to sign for or on behalf of the LNH.
7. **Fresh Contract**:- After expiry of the duration of the contract, the assignment may be extended further based on satisfactory performance. Fresh contract may be signed with same person subject to satisfactory performance during the earlier contract period. Old contract will not be renewed.
8. A consolidated remuneration will be paid for each completed calendar month and for any period of less than one month, the payment will be made on pro-rata basis. No other service benefits, allowances are admissible.
9. His/Her appointment is subject of being declare medically fit by the Medical Board of this hospital.
10. Other condition of service will be governed by relevant rules and orders from time to time issued by the Competent Authority/Govt. NCT of Delhi.
