I.EDUCATIONAL QUALIFICATIONS:

The applicant must possess Graduation from a recognized University in India and has passed the Government Technical Examination in Typewriting by Higher Grade in English and if such persons are not available, passing Government Technical Examination in Typewriting by Lower Grade in English will be considered, as per Rule 6 (2) (g) A.P. State Legal Service Authority Service Rules, 1999. The applicants who possess technical qualifications like Computers, Shorthand etc., will be given preference.

II.AGE LIMIT:

The applicant must have completed 18 years and must not have completed 42 years as on 01-09-2023 as per G.O. Ms.No.101, General Administration (SER.A) Dept., 30-09-2022 r/w. A.P. State Legal Services Authority Service Rules, 1999.

Provided that the upper age limit of 42 years is relaxable by 5 years in respect of the persons under Scheduled Castes/Scheduled Tribes/Backward Classes and EWS.

Provided that the upper age limit of 42 years is relaxable by 10 years in respect of physically disabled persons.

III.METHOD OF RECRUITMENT:

- 1. A Written Examination and Skill Test will be conducted depending upon the number of applications received and as per the directions of the Committee, constituted for selection and appointment of staff for Permanent Lok Adalat for Public Utility Services (PLAPUS) at Vizianagaram,
- 2. An Interview will be conducted to the candidates who qualified in the written examination and skill test as per the directions of the Committee, constituted for the said purpose.
- 3. The decision of the Committee, constituted for selection and appointment of staff for Permanent Lok Adalat for Public Utility Services (PLAPUS) at Vizianagaram, shall be final with regard to the said recruitment process.
- 4. Merely attending and securing minimum qualifying marks will not vest any applicant with a right to be considered for the selection.
- 5. No person shall be eligible for appointment unless he/she satisfies the following conditions:
 - That he/she is of sound health, active habits and free from any bodily 1) defects or infirmities rendering him/her unfit for the appointment.
 - That his/her character is such as to quality him/her for such service. ii)
 - He/she must be citizen of India. 111)

VI.GENERAL INSTRUCTIONS:

- The applicants shall indicate their local/non local status in the application.
- 2. Merely applying for a post will not give any right to any person to be considered for appointment.

- 5. No person, who has been dismissed from a State or Central Government service or from the service of undertaking of Central or State Government or local or other Authorities shall be eligible for appointment.
- 6. No person, who has been convicted by a Court of Law for an offence involving moral turpitude, shall be eligible for appointment.
- 7. No TA and DA will be paid to the candidates who appear for Written Test, Skill Test and Interview.
- 8. Candidates resorting to or bringing any influence of any kind will be summarily disqualified and they are liable for prosecution as per Law.
- 9. The particulars furnished by the applicant in the application form will be taken as final. Candidates should, therefore, be very careful in filling the application.

- 10. Correspondence will not be entertained by this Authority under any circumstances. Incomplete/incorrect application will summarily be rejected at any stage
- 11. If suppression of information/furnishing of false information is noticed, either in the application or in the enclosures, at any stage before the final selection, the application of the candidate will summarily be rejected.
