**Note:** A candidate, before appearing for the test, shall produce a medical certificate certifying that he/she is medically fit.

(iv) Qualifying in the NET conducted for the purpose by the UGC or SET accredited by the UGC. Director of Physical Education holding Ph.D. is exempted from NET. Candidates holding Ph.D. degree who are already in the University system and have obtained Master's degree prior to 1991 will be given relaxation of 5% from 55% to 50% of marks for appointment to the post of College Director of Physical Education, Government Colleges.
