**Tenure of Contract:**

1. For **Contractual FTS** - Full-time specialist on contractual basis shall be recruited for a period of 1 year with annual evaluation and term renewed every year based on satisfactory performance or till regular incumbent joins, whichever is earlier
2. For **Contractual PTS**-Part time specialist One year on contract from the date of joining or till regular incumbent joins, whichever is earlier.
3. For **(Contractual) Senior Resident**- One year on contract or till regular incumbent (GDMO) joins, whichever is earlier . The Contract will be extendable for a further period based on satisfactory performance.

**Qualification:**

**Full Time/ Part Time Contractual specialist** : MBBS with PG Degree or equivalent/ PG Diploma in concerned specialty from recognized university and registered with Medical Council of India/ State Medical Councils.

**Senior Resident (Contractual):** MBBS with PG Degree or equivalent/ PG Diploma in concerned specialty from recognized university or Non-PG doctors having atleast 2 years working experience after MBBS in the same discipline and registered with Medical Council of India/ State Medical Councils. Any discretion if arises be resolved by MS ESICH korba .

**Experience:**

**Full Time/ Part Time Contractual specialist:** PG Degree with 3 years experience or PG Diploma with 5 years experience in respective specialty after PG be preferred based on availability of applicants. Any discretion if arises be resolved by MS ESICH korba.

**Senior Resident (Contractual)** : MBBS with PG Degree or equivalent/ PG Diploma in concerned specialty from recognized university or Non-PG doctors having atleast 2 years working experience after MBBS in the same discipline (department)and registered with Medical Council of India/ State Medical Councils . Any discretion if arises be resolved by MS ESICH Korba .

**Consolidated remuneration:** Payment and remuneration shall be guided by instruction on subject from ESICH HQ office time to time .However, current Consolidated pay for Korba (z category city)will be applicable as per ESIC HQ letter number **OM Z-11012/51/2022-MED-VI Dated 08/12/2022 .**

  - a) Charges for Emergency visit, if willing: Rs 15,000/-,
  - b) Additional Remuneration beyond 16 hours/week: Rs 800/- for every additional hour.  
\*Additional hours of work/Emergency visits is to be justified by Medical Superintendent.
- 3) **Senior Resident (Contractual):** Rs 114955/- (One lakh fourteen thousand nine hundred fifty five) only per month.

**Duties:**

- 1) **Full Time Contractual Specialist:**  
Working hours: 09.00 AM to 04.00 PM on week days and 09.00 AM to 01.00 PM on Saturdays. Should make emergency visit as and when it is required.
- 2) **Part Time Contractual Specialist:**  
Working hours: 04 hours a day for 04 days in a week (Duty hours will be decided as per need and directions of competent authority).
- 3) **Senior Residents (Contractual):**  
The duties of doctors will be assigned by medical superintendent .They will be required to attend emergency duties as per assigned by Medical superintendent. Senior Residents will be entitled leave as per rule by ESIC HQ.

**General instructions:**

1. The recruitments will be purely on contractual basis and selected candidates will have no claim for regularization of the service in the ESIC hospital Korba .
2. Candidates seeking Reservation / Age relaxation benefits under SC/ST/OBC(NCL) category must ensure that they are entitled to such reservation as per eligibility prescribed in the notice and as per the instruction issued by Government of India. They should also be in possession of the certificates in the prescribed format of Govt. of India in support of their claim. Candidates seeking reservation under EWS category, should submit their EWS certificate as prescribed vide Govt. of India, Department of Personnel & Training OM No. 36039/1/2019-Estt.(Res) dated 31-01-2019. Candidates claiming reservation/age relaxation under OBC (NCL)category should submit their OBC certificate as prescribed vide Govt. of India, Department of Personnel & Training OM No. 36012/22/93-Estt.(SCT) dated 15-11-1993.
3. Private practices of any kind will not be allowed for full time contractual engagements.
4. ESIC may increase or decrease or cancel filling up of any or all the post without assigning any reasons at the discretion of the Appointing Authority. In case of any discrepancy, Latest circular will be final, thereafter if any

- issue still persist , decision of Medical Superintendent will be final.
5. No TA/DA will be paid to the candidates for appearing in the interview.
  6. Application should be submitted in the prescribed form appended below. It should be filled up in block/capital letters by the candidate in his/her own handwriting.
  7. Incomplete or Unsigned applications or the applications received without the self-attested copies of mark sheets/certificates in support of educational qualification, proof of age (Birth certificate or class 10th marksheet), application fee, caste certificate, experience certificates, photographs and those received after the last date of receipt of applications are liable to be rejected without any communication to the candidate.
  8. ESIC will not undertake detailed scrutiny of applications for eligibility and other aspects for calling candidates for interview and, therefore, the candidature will be accepted only provisionally. The candidates fulfilling the eligibility criteria for the post will be called for interview on the basis of information furnished by them in the application form. Mere submission of application does not confer any right to the candidates for being called for interview. Before applying, candidates are advised to go through the requirements of essential qualification, age, experience etc. and satisfy themselves that they are eligible for the post. At the time of verification/submission of documents on the day of interview, if any claim made in the application is not found substantiated, the candidature of the candidate will be cancelled and the decision of MS ESIC hospital Korba in this regard shall be final.
  9. Wrong declarations/submission of false information or any other action contrary to law shall lead to cancellation of the candidature at any stage.
  10. Hostel accommodation/ quarters will not be provided.
  11. The candidate who is in service should submit "No Objection Certificate" from the employer at the time of interview.
  12. The posts are contractual and the contractual engagement may be terminated/ discontinued by either side giving one month prior notice before resigning or will have to pay an amount equivalent to one month's remuneration in lieu of the notice period.
  13. The decision of the Medical Superintendent will be final on all aspects of selection and no further correspondence will be entertained under any circumstances.
  14. In case of selection, OFFER OF APPOINTMENT will be issued as per requirement.
  15. The selected candidate will be required to deposit security of Rs. 30000/- (Rupees Thirty thousand only) through Demand Draft in favor of "ESI Fund Account No.1" , Korba at the time of joining. The same is refundable after completion of contract period and on production of "No dues certificate". If the selected candidates resigns/terminates his/her contract without prior notice, the amount deposited as security money will be forfeited.
  16. In case a candidate wish to apply for post of part time specialist post which has been advertised as full time specialist post and no person is available for FTS post, then he/she may be given the post subject to discretion of MS ESICH KORBA. However that candidate has to mandatorily opt for emergency calls at the prescribed rates. As soon as Full time specialist /regular incumbent joins that particular post , his/her services will be terminated as per rules.
  17. Qualifications with regard to experience are relaxable at the discretion of the Appointing Authority on recommendation of the Selection Committee in case of candidates found otherwise well qualified.
  18. The Qualifications regarding experience in respect of Scheduled Castes and the Scheduled Tribes candidates is relaxable based on the guidelines issued by the Government of India from time to time.
  19. Work experience after obtaining the P.G. degree/ diploma will be reckoned as on a month before interview. Experience certificates duly signed by the Head of Department indicating clearly the period and nature of work, should be submitted

- along with the application form.
20. The MBBS or equivalent qualification and Post Graduate Qualification should be recognized by the MCI/State Medical Council Chhattishgarh. The candidates are advised to attach the certificate of registration/recognition of their MBBS or equivalent qualification and Post Graduate Qualification with the MCI/State Medical Council Chhattisgarh. The candidate whose MBBS or equivalent and Post Graduate Qualification is not recognized by the MCI/State Medical Council Chhattisgarh, he/she will not be eligible for the above post.
  21. The selected Full Time/Part Time Super Specialist/Senior Residents will be required to submit acceptance/consent letter in writing before appearing for Medical examination. The Selection is subject to the candidates proving their medical fitness.
  22. Absence from work for a period of 15 days without proper permission of competent authority will amount to voluntary abandonment of engagement and no further order of disengagement shall be necessary.
  23. Selected candidate will have to sign contract of agreement on bond paper of Rs 100. The cost of bond paper should be borne by selected candidate only.
  24. The number of vacancies may changed without prior notice.
  25. The duties of doctors will be assigned by medical superintendent. They will be required to attend emergency duties as per assigned by Medical superintendent.
  26. In case of joining GDMO the relieving of Senior Resident will be on last come first go principle.
  27. Senior Residents will be entitled for leave as per ESIC HQ rules.
