

The last date of submitting application through email is 10.06.2023(5.00 PM). The signed hard copy of the application along with certified copies of all certificates/ documents, two copies of recent passport size photograph (one should be pasted on the form), and a non-refundable application fee of Rs.500/(SC/PWD candidates are exempted) in the form of Demand Draft drawn in favour of Director, NERIST and payable at SBI NERIST (Code No. 18744) Nirjuli, Arunachal Pradesh should reach the Registrar, NERIST, Nirjuli, PIN —791 109, Arunachal Pradesh by Registered/Speed Post only, superscribing the envelope as "Application for the post of Assistant Professor".
