अधिसूचना

रेलवे बोर्ड के पत्र सं.E(NG)II/2020/RC-4/2(Pt-2) दिनांक 03.03.2023 में उल्लेखित शर्तों के आलोक में निर्माण संगठन में प्रक्रियाधीन प्रोजेक्ट, जिसमें कि भूमि अधिग्रहण हेतु वन/ वन्य जीव संबंधी क्लीयरेन्स का मामला सम्मिलित है, में कार्य की आवश्यकता हेतु **दिल्ली अथवा उत्तर प्रदेश अथवा हरियाणा राज्यों के वन विभाग** से सेवानिवृत्त कर्मचारियों की अनुबन्ध के आधार पर पुनःतैनाती (Re-engagement) किए जाने का निर्णय लिया गया है, जिसका विवरण निम्नवत है –

5. योग्यता (Eligibility)

1. अभ्यर्थी दिल्ली राज्य अथवा उत्तर प्रदेश राज्य अथवा हरियाणा राज्य के वन विभाग से सेवानिवृत्त हो चुका हो तथा उसे वन (पेड़ों की कटाई)/ वन्य जीव संबंधी क्लियरेंस कराए जाने से संबंधित कार्य का अनुभव हो।
2. अभ्यर्थी ग्रेड पे-4200 से ग्रेड पे-5400 तक के पद (उप वनक्षेत्रपाल, वनक्षेत्रपाल, आदि) से सेवानिवृत्त हुआ हो।
3. अभ्यर्थी की आयु Walk-In Interview के समय 65 वर्ष से कम हो।
4. अभ्यर्थी को आवश्यक चिकित्सकीय जाँच के उपरान्त ही पुनः-तैनात (Re-engage) किया जाएगा।

6. पुनः-तैनाती (Re-engagement) हेतु अन्य नियम व शर्तें -

- I. चयनित कर्मचारियों की पुनः-तैनाती (Re-engagement) का कार्यकाल दिनांक 21.02.2024 अथवा आयु 65 वर्ष की आयु पूर्ण होने तक ही मान्य होगी।
- II. पुनः-तैनाती (Re-engagement) के समय अभ्यर्थियों को मासिक पारिश्रमिक व भत्ते इत्यादि का भुगतान रेलवे बोर्ड के पत्रांक E(NG)II/2020/RC-4/2(Pt-2) दिनांक 03.03.2023 के अनुरूप दिया जाएगा।
- III. पुनः-तैनात (Re-engaged), अभ्यर्थी की सेवा दिनांक 21.02.2024 अथवा कार्य समाप्ति अथवा उनके 65 वर्ष पूर्ण (जो भी पहले हो) होने पर स्वतः समाप्त मानी जाएगी।
- IV. पुनः-तैनात (Re-engaged), अभ्यर्थी की सेवाएँ उत्तर रेलवे के भौगोलिक क्षेत्र में कहीं भी ली जा सकती हैं।
- V. पुनः-तैनाती (Re-engagement) के सम्पूर्ण नियम व शर्तें, अभ्यर्थी के अंतिम रूप से चयनित होने के पश्चात दिए जाने वाले अनुबन्ध पत्र के साथ उपलब्ध कराए जाएंगे।
- VI. सभी पुनः-तैनात (Re-engaged) अभ्यर्थियों पर समय-समय पर रेलवे बोर्ड अथवा रेलवे के सक्षम प्राधिकारी द्वारा जारी नियम लागू होंगे।
- VII. अभ्यर्थियों का चयन, एक चयन समिति के माध्यम से किया जाएगा।

7. आरक्षण : केन्द्र सरकार के नियमानुसार आरक्षण लागू होगा।

8. अन्य सामान्य निर्देश -

- 1) साक्षात्कार हेतु योग्य पाए जाने वाले अभ्यर्थियों को उचित माध्यम (पत्राचार, दूरभाष) द्वारा सूचित किया जाएगा।

In terms of Railway Board's letter no.E(NG)II/2020/RC-4/2(Pt-2) dated 03.03.2023, it has been decided to Re-engage the retired officials of Forest department of Delhi, Uttar Pradesh & Haryana states on contract basis for ongoing Projects of Northern Railway Construction Organisation to help expedite matters related to forest/wild life clearances. The details are hereunder -

- 5. Eligibility Criteria**

1. Candidate should be a retired person from the forest department and he/she should have working experience of Forest department related to forest/wild life clearances etc.
2. He/she should have been retired from the post (of Dy.Forest Range Officer, Forest Range Officer etc.) carrying Grade Pay-4200 to Grade Pay-5400.
3. He/she must below the age of 65 years at the time of Walk-In Interview.

4. He/she will be Re-engaged only after required medical fitness.

6. Other Terms & Conditions of Re-engagement –

- I. The period of Re-engagement would be till attaining the age of 65 years or till 21.02.2024, whichever is earlier.
- II. Candidates would be given monthly remuneration and allowances at the time of Re-engagement, in terms of Railway Board's letter no.E(NG)II/2020/RC-4/2(Pt-2) dated 03.03.2023.
- III. The services of Re-engaged such persons would be treated as terminated on date 21.02.2024 or his/her completion of work or attaining the age of 65 years, whichever is earlier.
- IV. The services of Re-engaged person can be taken anywhere in the geographical jurisdiction of Northern Railway.
- V. The detailed terms & conditions of Re-engagement would be provided/given to the candidate alongwith the Contract Agreement after his/her selection in all respect.
- VI. All such Re-engaged candidates would be governed under the rules issued by Railway Board or competent authority from time to time.
- VII. Candidate would be selected by, a Selection Committee.
- VIII. The below mentioned self-attested documents must be enclosed alongwith original application -
 - 1) 2 Passport sized photograph.
 - 2) Date of birth proof (High-School/ Equivalent)
 - 3) Caste Certificate in support of SC/ST/OBC
 - 4) Photocopy of PPO of retired person
 - 5) Service Certificate (Got at the time of retirement)

7. Reservation : Applicable according to Central Government rules.

- 4) Candidates selected for Walk-In Interview would be informed by appropriate means of communication Correspondence through Dak, Telephone etc.).
 - 5) No TA/DA would be given/permissible for Walk-In interview.

Sub: Re-engagement of retired State Government officials in exigencies of services in projects where land acquisition is involved.

Ref: (i) Board's letter No. E(NG)II/2007/RC-4/CORE/1 dated 28.11.2019 (RBE No. 207/2019)
(ii) Board's letter No. E(NG)II/2020/RC-4/2(Pt.2) dated 22.12.2020(RBE No. 113/2020).

It had been decided vide Board's letter dated 22.12.2020 that no retired employees should be re-engaged after 02.12.2020 except in para medical category.

2. It has now been decided to permit Railways to engage retired State Government officials from forest/revenue departments on contract basis for work related to Survey, updation of land records, coordination with State Government agencies for forest/ wild life clearances in projects where land acquisition is involved.

3. The total number of such engagements may be restricted to 10 in each Zonal Railway. The scheme has been extended for a period of one year beyond 21.02.2023 i.e. upto 21.02.2024. Powers for such engagement shall be exercised by the General Managers only with Finance concurrence.

4. As regards remuneration, allowances and leave, these will be as per OM No. F.No. 3-25/2020-E.IIIA dated 09.12.2020 of Department of Expenditure, Ministry of Finance, Government of India which are as under –

- (i) A fixed monthly amount shall be admissible as remuneration during the contract period, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of the contract.
- (ii) No increment, Dearness Allowance and HRA shall be allowed during the term of the contract.
- (iii) An appropriate and fixed amount as Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement. The amount so fixed shall remain unchanged during the term of appointment. However, they may be allowed TA/DA on official tour, if any, as per their entitlement at the time of retirement.
- (iv) Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service.


5. The re-engaged retired employees shall sign an agreement of confidentiality with the Railway containing a clause on Ethics and Integrity.

6. The following conditions stated in Board's letter No. E(NG)II/2007/RC-4/CORE/1 dated 28.11.2019 shall also be observed while re-engaging these retired employees-

- i. Railway should give adequate publicity to such re-engagement, including by putting it on Railway websites.
- ii. While re-engaging such staff, medical fitness of the appropriate category should be obtained from the designated authorities as per existing practices.
- iii. Suitability/competency of the staff should be adjudged before such re-engagement.
- iv. Maximum age limit for such re-engagement shall be 65 years.
- v. The integrity aspect should also be checked while permitting such re-engagement.

7. Clear fund availability should also be ensured for re-engaging these retired employees and the expenditure towards this arrangement may be charged to the same head against which the expenditure was charged in the past when such arrangements were in force prior to issuance of Board's letter dated 22.12.2020.
