b) Tenure:

The contractual engagement will be for a period of **03 years extendable for another 01 year (12 KICs) and 3 Years (2 existing KICs)** based on satisfactory performance, periodic reviews, result-oriented, etc., and at all times coterminous with the Khelo India Scheme.

c) Tax Deduction at Source:

The Income Tax or any other tax liable to be deducted, as per the prevailing rules will be deducted at source before effecting the payment, for which the Sports Authority of Andhra Pradesh will issue TDS /Service Tax Certificates, as applicable.

d) Other Allowances:

No TA/DA shall be admissible for joining the assignment or on its completion. No other facilities like DA, Accommodation, Residential Phone, Conveyance Transport, Personal Staff, Medical reimbursement, HRA and LTC etc. would be admissible.

e) Extension:

The performance of the selected candidates would be continuously reviewed and the extension will be considered on the basis of periodic review/requirement.

CONFIDENTIALITY

a) Selected persons will not be allowed to publish a book or a compilation of articles or participate in a radio broadcast or contribute an article or anonymously or pseudonymous in the name of any other person, if such book, article, broadcast, use any information that he/she may gather as part of this assignment

b) During the period of engagement with Sports Authority of Andhra Pradesh, Employee would be subject to the provisions of the Indian Official Secret Act, 1923

and will not divulge any information gathered by him/her during the period of his/her engagement to anyone who is not authorized to know

c) The Selected personnel at no instance can represent or give opinion or advice to others in any matter, which is adverse to the interest of the Government.

OTHER CONDITIONS

a) The applications received will be scrutinized/ shortlisted on the basis of relevant experience and job description and the eligible candidates will be called for an Interview at a cost to the applicant.

b) Candidates who applied for more than one post will be interviewed only once.

c) In case he/she is required to proceed outstation from the place of posting on tour for official duty, he/she will be entitled to TA/DA as admissible under the rules.

d) In case the performance of the Candidate is not found satisfactory, his/her services will be discontinued after giving one month notice period.

e) Without any prejudice to the above condition, the candidate will be terminated from his services with immediate effect without any obligations, in case the candidate is found guilty of violating any of the conditions contained in the terms of employment or is guilty of any misconduct including negligence of duties, unauthorized absence, etc.

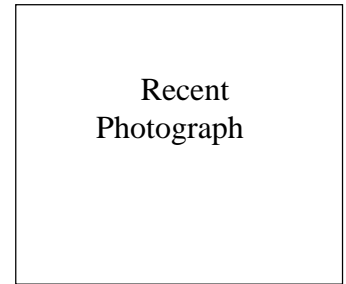
