II. ESSENTIAL QUALIFICATIONS

For the Department of Management Studies: As per 'AICTE Regulations on Pay Scales, Service Conditions and Minimum Qualifications for the appointment of Teachers and other Academic Staff such as Library, Physical Education and Training & Placement Personnel in Technical Institutions and Measures for the Maintenance of Standards in Technical Education – (Degree) Regulation, 2019' and subsequent amendments, if any.

For other Disciplines:-As per 'UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education, 2018' and subsequent amendments, if any.

III GENERAL REQUIREMENTS/INSTRUCTIONS

1. A relaxation of 5% (60% to 55% for Management Disciplines and 55% to 50% for rest of the Disciplines) shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC) Non-Creamy Layer / Differently abled [(a) Blindness and Low Vision; (b) Deaf and Hard of Hearing; (c) Locomotor Disability including Cerebral Palsy, Leprosy Cured, Dwarfism, Acid-attack victims and Muscular Dystrophy; (d) Autism, Intellectual Disability, Specific Learning Disability and Mental Illness; (e) Multiple Disabilities from amongst persons under (a) to (d) including deaf-blindness)] for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark.

- **2**. A relaxation of 5% shall be provided to the Ph.D. Degree holders who have obtained their Master's Degree prior to 19th September, 1991.
- **3.** A relevant grade which is regarded as equivalent of 55%, wherever the grading system is followed by a recognized university, at the Master's level shall also be considered valid. The candidate must submit certificate of conversion of Grade to Percentage issued by the concerned Degree awarding University.
- 4. The time taken by candidates to acquire M.Phil. and / or Ph.D. Degree shall not be considered as teaching / research experience to be claimed for appointment to the teaching positions. Further, the period of active service spent on pursuing Research Degree simultaneously with teaching assignment without taking any kind of leave, shall be counted as teaching experience for the purpose of direct recruitment.
- **5**. Candidates claiming previous service / experience should submit certificate fulfilling the conditions as per Clause 10 of UGC Regulations, 2018.
- 6. The prescribed essential qualifications are the minimum and mere possession of the same does not entitle candidates to be called for interview. Where the number of applications received is large and/or where it will not be convenient or possible to interview all the candidates, the University at its discretion may restrict the number of candidates to a reasonable limit on the basis of higher qualifications/experience than that prescribed in the Advertisement. Further, the University may also fill up the posts advertised on short-term contract basis, if necessary.
- 7. The proof of Peer Reviewed Journal status, Impact Factor, Authorship Claim etc. should be provided with valid documents, otherwise the marks will not be allotted as per the claim. University will not be responsible for any mistakes made due to not providing valid proof. Only Research Publications from journals indexed in UGC CARE list will be considered w.e.f 14.06.2019.
- **8.** Candidates possessing foreign degrees should submit Equivalence Certificate issued by the Association of Indian Universities (AIU) at the time of interview, if called for.
- **9.** Selection will be made on the basis of candidates' performance in the interview. The University may resort to methods such as seminar/colloquium/teaching also for selection.
- 10. The University reserves the right to: (a) not filling up any or all posts advertised, (b) offer a post at a lower/higher level than notified, depending upon the qualifications, experience and performance of a candidate, and (c) relax any of the desirable qualifications/experience at its discretion for reasons to be recorded.
- 11. Outstation candidates (beyond 30 Km) belonging to SC/ST/PwBD categories called for interview will be reimbursed single second class railway fare from station to station towards journey expenses on production of ticket and proof of category (as per GoI rules). The above mentioned concessions shall not be admissible to those SC/ST/ PwBD candidates who are already in Central/ State Government Services.

- 12. The pay of the selected candidates will be initially fixed in the minimum Scale/Level of pay in the Pay Matrix. However, the candidates may apply for protection of pay and the University may consider the same strictly as per GoI rules for fixation of pay. Fixation of pay for re-employed Pensioners shall be strictly as per pay fixation rules of re-employed pensioners issued by the GoI.
- 13. The appointed candidates shall be governed by the National Pension Scheme (NPS).
- 14. The teachers appointed shall be assigned with academic or administrative responsibilities in addition to their regular teaching and research activities.
- **15**. No interim queries regarding interview/selection will be entertained.
- 16. Canvassing in any form will be a disqualification.
- 17. In case of any disputes, any suits or legal proceedings against the University, the jurisdiction shall be the Hon'ble High Court of Kerala.
- **18**. The University will issue call letters to the shortlisted candidates and other correspondences through email only. Candidates are requested to mention their email ID clearly in their applications.
- 19. Any time even after appointment if it is noticed that the candidate does not possess the eligibility prescribed by the UGC/AICTE Regulations (as applicable) or that the claim made by him/her with respect to the qualifications/experience/other credentials are false or misrepresentation of facts, then his/her appointment shall be terminated forthwith. The candidate shall be held solely responsible for the same and its consequences.
- 20. Any errors and omissions detected in the Advertisement and the process of selection are subject to rectification by the University.
