

## Terms and conditions:

1. The interview for the above posts will be conducted through in person at ICAR-NBAIR, Bengaluru.
2. The interview will be conducted by strictly following COVID 19 guidelines given by Government of India. All the candidates should follow the COVID 19 guidelines as such, if any deviation will not be allowed to attend the interview. **No candidates will be allowed to enter ICAR-NBAIR campus without mask.**
3. Only Indian citizens are eligible for appearing in the interview.
4. Age limit: Maximum age is 35 years for men and 40 years for women and age relaxation for SC/ST/OBC is applicable as per Govt. Of India/ICAR rules as on last date of submission of application through email. Applicants with minimum eligibility alone need to send/appear for interview.
5. Period of contract service up to **9<sup>th</sup> February, 2025** or co-terminus of project whichever is earlier.
6. The above positions are purely temporary basis and co-terminus with the project subject to satisfactory performance which will be reviewed every 6 months by the Principal Investigator.
7. The selected candidates shall have no right/claim for regular appointment or absorption at ICAR-NBAIR at any point of time. The present post is purely temporary and co-terminus with respective Project/scheme.
