NOTIFICATION FOR APPOINTMENT ON CONTRACT/ DEPUTATION

Bangalore Metro Rail Corporation Limited (BMRCL), a 50:50 Joint Venture of Government of India and Government of Karnataka, is a Special Purpose Vehicle (SPV) entrusted with the responsibility of implementing the Metro Rail Project in the city of Bengaluru.

BMRCL has successfully completed the Phase – 1 of the Metro Rail Project having a route length of 42.30 Kms, which is currently under operation consisting of Green Line (North-South) and Purple line (East-West) comprising of 40 Metro stations both elevated and underground. Phase –2 of the Metro Rail Project consists of 75.06 Kms with 4 extensions to the existing lines of Phase 1 and 2 new lines which is currently under various stages of completion.

BMRCL is also implementing another 58.19 kms of Metro Rail Project, consisting of Phase 2A from Central Silk Board Jn to KR Pura and Phase 2B from K R Pura connecting the Bangalore International Airport.

BMRCL is presently operating 69.70 Kms of Rail Network across the city of Bengaluru with 64 Metro Stations, both elevated and underground, and expected to have about 100 KMs of operational network by end of December 2023.

BMRCL invites applications from qualified and experienced personnel for appointment to the post of Director (Operations & Maintenance) on Contract / Deputation basis.

1. NAME OF THE POST AND NO. OF POSTS:

2. JOB DESCRIPTION AND RESPONSIBILITIES:

The Director (Operations & Maintenance) will be a member on the Board of Directors of BMRCL and will report to the Managing Director.

He shall be responsible for operations and maintenance of operational assets, commercial, safety and security of the Metro network opened for revenue services. He will closely associate with the Project Wing for opening of the new Metro lines. He will also endeavour to maximise revenue through both Fare Box as well through Non Fare Box sources by closely coordinating with the concerned Department/s responsible for property development and connectivity.

2.1 ON CONTRACT BASIS:

Minimum age 50 years but not more than 57 years as on the date of this notification.

Qualification and Experience:

Degree in Electrical/Electronics and Communication Engineering/Mechanical Engineering from an Institution of repute.

Should have worked in SAG or NF-HAG grade and have proven track record of 25 years in Group A/Executive Service in Railways, Metro Rail Corporations.

Candidates presently working in BMRCL and who meet the eligibility criteria may also apply provided they have served in the grade of General Manager/Chief Engineer in BMRCL for at least 2 years. The maximum age criteria in such case may be relaxed by one year i.e. upto 58 years as on the date of this notification.

Officer having experience of Metro Rail Operations shall be preferred.

Desirable:

Experience in Maintenance and Operations of Rolling Stock (EMU/DMU/Electric/Diesel E) and Metro Rolling Stock or Railway Electrification or signaling and telecommunication.

2.2 ON DEPUTATION:

Minimum age 50 years but not more than 57 years as on the date of this notification.

Qualification and Experience:

Degree in Electrical/ Electronics and Communication engineering/ Mechanical Engineering from an Institution of repute:

Should have worked in SAG or Non Functional HAG and have proven track record of 25 years in Group A Service IRSEE/IRSME/IRSSE in Railways, including Railway PSUs/Metro Rail Corporations.

Officer having Experience of Metro Rail Operations shall be Preferred.

3. GENERAL CONDITIONS:

- The tenure of contract appointment shall be five (5) years within the maximum age of retirement. The contract term may be extended by two (2) more years at the discretion of the Board. Absorption shall be given preference over deputation.
- Candidates who have been shortlisted will only be called for interview by a Selection Committee constituted for the purpose by the Competent Authority.
- The experience is post qualification and the minimum required. Mere possession of minimum experience does not confer any right to be called for interview / selection.
- To & fro Air Fare (Economy class) will be reimbursed to outstation candidates on production of Air Tickets and one way (Arrival) Boarding pass.
- Applications with Insufficient / Incomplete information will be rejected.
- Any canvassing by or on behalf of the candidates or to bring political or other outside influence with regard to selection/appointment shall be a disqualification.
- Self-Attested photocopies of certificates and Marks Sheets in proof of Educational Qualification (X standard / SSLC and onwards) and Self attested Photocopies of Experience Certificate/s with latest salary certificate containing detailed particulars of Basic Pay, Scale of Pay, Perks etc., shall be attached while submitting the application. Originals should be produced for verification at the time of interview.
- In case of candidates from Government / Quasi Government / PSU they should forward their applications through proper channel or 'No Objection letter' from the present Employer will have to be produced at the time of interview. Vigilance clearance letter of the candidates duly certified by the present Employer should be submitted for consideration of their candidature for the post.

4. MEDICAL STANDARD:

Applicants should be of sound health and should meet the medical standards prescribed by the Company. Appointment of selected candidates will be subject to medical fitness. No relaxation in health standard is allowed.

5. PAY SCALE FOR DIRECT RECRUITMENT

Consolidated remuneration of Rs.3,00,000/-per month (Rs.2,75,000 pay and Rs. 25,000/- HRA) + other allowances/perks applicable to the post of Functional Directors in the Company. In the case of deputationists, the salary will be as applicable in their parent organization with applicable Deputation Allowance apart from other allowances/perks applicable to the post of Functional Director in the Company.

6. TENURE AND AGE OF RETIREMENT:

The tenure of the Director is for 5 years or 60 years of age, whichever is earlier, extendable upto the age of 62 years at the discretion of the Board.
