Ministry of Tribal affairs was set up in 1999 with the objective of providing a more focused approach towards the integrated socio-economic development of the Scheduled Tribes in a coordinated and planned manner. To provide the best quality education to the tribal children in their own environment, it has been decided that every block with more than 50% ST population and at least 20,000 tribal persons, will have an Eklavya Model Residential School (EMRS). In order to function EMRS effectively, an Autonomous Society viz National Education Society for Tribal Students (NESTS) has been set up at the Central level under Societies Registration Act 1860.

To achieve the above objective, NESTS is engaging qualified and experienced professional for following post purely on contractual basis for a period of 1 year which may be extended/terminated as the approval of the Competent Authority. The incumbent shall not have any claim for regular appointment under the Ministry/NESTS.

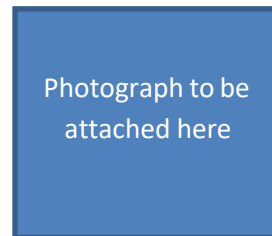
