- ii. Applications received after expiry of last date of submission will not be accepted.

General Conditions:

- The last date for receipt of Application Forms, as stipulated above, shall be the cutoff date for determining the eligibility for the post. Any qualification/experience acquired thereafter shall not be considered.
- The application will be accepted in the prescribed format in online mode through University website <u>www.</u> <u>skuastkashmir.ac.in</u> only. No other means/mode of application will be accepted.
- The applicants shall carefully fill the details in the online application form and the information /details so submitted shall be treated as final for the purpose of determining eligibility of the candidate and no claim, whatsoever, on this account, shall be entertained subsequently.
- Reservation for various categories shall be applicable in accordance with the provisions of Jammu and Kashmir Reservation Rules 2005 read with S.O 127 of 2020 dated 20-04-2020.
- A candidate seeking his/her consideration under any reserved category must be in possession of valid category certificate as on the cutoff date of the submission of online application forms. Under process certificate issued by the authorities shall not be construed. Further, the Category certificates issued after the cutoff date shall in no case be entertained.
- Only relevant qualification(s) including category status etc. should be recorded in the Application Form, which shall be in possession of the candidate on or before the last date for receipt of Application Form.
- Canvassing by any candidate in any form will render him/her disqualified for the post.
