(ii) One year post qualification experience as Master/Chief Officer of a foreign going ship.

Note :

1. The Candidate appointed to the post of Pilot will undergo training for a period of 6 months and will be designated as Trainee Pilot. On obtaining the license after training, he/she will be designated as Pilot.
2. In addition to Basic pay, benefits like DA on industrial pattern, accommodation / HRA, Cafeteria allowance, NPS, Group Insurance, Medical facilities, Encashment of earned leave, etc, admissible as per Rules along with applicable Marine allowances.

General Instructions / Conditions:

1. While applying for the post, the applicant should ensure that he / she fulfills the eligibility and other norms mentioned above. In case, it is detected at any stage of recruitment that a candidate does not fulfill the eligibility norms and / or that he / she has furnished any incorrect / false information or has suppressed any material fact(s), his / her candidature will stand automatically cancelled. If any of the above shortcoming(s) is / are detected even after appointment, his / her services are liable to be terminated without any notice.
2. All qualifications should be recognized and approved in India by AICTE / UGC / appropriate Statutory Authority / Competent Authority.
3. The mere fact that a candidate has submitted the application against the advertisement would not bestow upon him / her, the right to be called for written test / interview / considered for selection process.
4. Employees working in Central & State Government / Semi-Govt./Govt. Autonomous Bodies/CPSEs must apply through proper channel or submit No Objection Certificate at the time of interview.

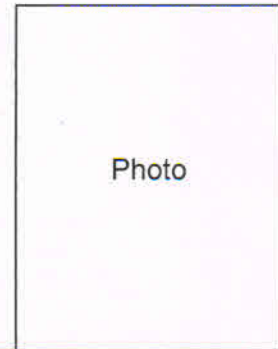
