#### : General Instructions :

- 1. Applicants must produce original testimonials, certificates and other documents in document verification and eligibility process.
- 2. Only print copy of online application with required enclosures will be accepted. Applicants must bring hard copy of Photocopies of the application along with all supporting documents relating to Age, Educational Qualifications, Caste, Physical Disability, Experience & other documents on or before Dt. 12/09/2023 till 04:00 PM or else the application will not be considered.
- 3. Applications incomplete in any respect will not receive any consideration at all and will be rejected.
- 4. The Last Date for feeling up Online Applications is fixed as 12/09/2023 till 04:00 p.m.
- 5. The candidates must possess the required qualifications at the time of last date for online application in the advertisement by the University i.e. 12/09/2023 till 04:00 PM Experience and qualification will be reckoned as on last date for Online Application. No updating of qualification and experience will be entertained after the last date.
- 6. Candidates for the post of Associate Professor must fill and attach Academic Performance Indicator (API) based Performance Based Appraisal System (PBAS) along with the print out of Online Application form, failing which the applications will be summarily rejected. The score provided against the given categories in each column must be supported by documentary evidence, without which no claim on account of Research/Academic score would be entertained.
- 7. Candidate applying for the post of Associate Professor must provide data for separate segment on Academic and Research Score in online application from as per UGC Regulations, 2018. Candidate must fill score in respective field for different categories 1 to 6 as per UGC Regulations, 2018, Annexure-2, Table 2. The total score of various categories must be entered at the end of the form in prescribed format.
- 8. Candidate has to submit conversion table from Grade/CGPA to percentage in case of mark sheet with Grade/CGPA without fail.
- 9. Candidates belonging to 'SEBC' category are required to pay application fees online Rs. 1,000/- (Rupees One Thousand). Application fee will not be refunded once the form has been submitted by the applicant.
- 9. Rules and Regulations of University, UGC Regulations, 2018 (Minimum Qualifications for Appointment of Teachers and Other Academic Staff in University), NCTE Regulation, 2014 and 2019 and regulations of Government of Gujarat shall be applicable to the post in the advertisement, and as updated from time to time.
- 10. A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC)(Non-creamy Layer)/Differentlyabled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever

- the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.
- 11. It is the sole discretion of University for filling any post. The University reserves the right to fill or not to fill any or all the posts, without assigning any reason and no notice will be issued in this regard.
- 12. The University shall verify the antecedents and documents submitted by candidates at any time during process, at the time of appointment or during the tenure of service. In case it is detected that the documents submitted by the candidates are fake or the candidates have undesirable clandestine antecedents/background and have suppressed the said information, his/her services shall be liable to be terminated.
- 13. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issuance of appointment letter, the University reserves the right to modify/withdraw/cancel any communication made to the candidates or process done in this regards.
- 14. Relaxation of 5% in qualifying marks for minimum eligibility will be given to SEBC (Non-Creamy Layer) candidate as per norms. A relaxation of 5% shall be provided, (from 55% to 50% of the marks) to the Ph.D. Degree holders who have obtained their Master's Degree prior to 19 September, 1991.
- 15. Candidates must also enclose a Certificate issued by Tahsildar/ Mamlatdar/Mandal Revenue Officer/Equivalent Competent Authority as a proof to this effect without which the application shall not be considered. Person applying for the posts reserved for SEBC category must produce Caste Certificate and Latest Non-Creamy Layer Certificate from Competent authority.
- 16. If any case, application for any particular post number is rejected or candidate is found ineligible for that particular post, his/her candidature will not be considered for any other post in any circumstances. No representation will be entertained in this regard.
- 17. Eligible candidates are Informed via email and they have to present for Document Verification/ Eligibility Process/ Interview Process.
- 18. Selection will be made on the basis of candidates' overall record and performance in the interview or any other method decided by the University. The University may use seminar/colloquium and/or any other mode as a method of selection.
- 19. Candidates already in service must submit a NOC from their employer and forward their applications (hard copy) through proper channel. In case the applicants are in service and delay is expected in getting endorsement of the employer concerned on the original application, the applicants may submit an advance copy of the application along with all enclosures directly (with or without the employer's endorsement on the advance copy). If the original application through proper channel has not been received on 12/09/2023, the applicants will have to submit a 'NO OBJECTION CERTIFICATE' along with Vigilance Clearance Certificate from his/her employer to the University at the time of interview/document verification.
- 20. Age of superannuation and salary for said post shall be as per Government of Gujarat/ UGC norms.
- 21. The University reserves the right to modify or withdraw the advertisement either partly or wholly at any time without assigning any reason to this effect. To fill or not to fill up some or all the posts advertised for any reasons whatsoever. To

- increase/decrease the number of posts after due procedure as per directions of Government of Gujarat from time to time Any edition/deletion and changes in matter of terms and conditions given in this notification of recruitment, as directed by concerned authority from time to time.
- 22. In case of any dispute/ambiguity that may occur in the process of selection, the decision of the Vice-Chancellor, Indian Institute of Teacher Education in all matter relating to eligibility, acceptance or rejection of applications, mode of selection, conduct of examination/ interview will be final and no query or correspondence will be entertained in this connection.
- 23. No person shall be recruited unless he/she is in good mental and bodily health and free from any physical defect that is likely to interfere with the efficient performance of his official duties. Before the candidates recruited directly are finally approved for appointment to the University, he/she shall be required to produce a medical certificate of physical fitness from whom the appointing authority specifies.
- 24. Candidates are advised to check regularly the University website <a href="www.iite.ac.in">www.iite.ac.in</a> and their email account for updates.
- 25. The candidate should possess required computer competency and should provide certificate for the same in accordance with provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006 or selected candidate shall, during his probation period, be required to pass qualifying examination for computer competence. The candidate should also possess language proficiency of Gujarati and Hindi as per norms of Government of Gujarat or selected candidate shall, during his probation period, be required to pass qualifying examination for required language proficiency.
- 26. The prescribed qualifications and experience are minimum and the mere fact that a candidate possesses the same will not entitle him/her for being called for interview.
- 27. Canvassing In any form on behalf of any candidate will disqualify the candidate.
- 28.
