VACANCY CIRCULAR

1. It is proposed to fill up the One (01) post of Assistant and One (01) post of Upper Division Clerk in Regional Office of the Ministry of Environment, Forests and Climate Change at Dehradun on deputation basis. Qualifications required for the posts can be seen at **Annexure-I** and **Annexure-II** respectively of the vacancy circular in the website of the MoEF&CC, Govt. of India at www.moef.nic.in or can also be

obtained directly from the Regional office, MoEF&CC, Dehradun.

- 2. The terms and conditions of the candidates selected for appointment on deputation basis will be governed as per the conditions laid down in the Government of India, Department of Personnel & Training's OM No. 6/8/2009-Estt.(Pay-II), dated 17.6.2010, as amended from time to time.
- 3. The period of deputation will be initially for three years and is likely to be extended further up to five years as per the guidelines of DOP&T. The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or other Office/Department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment of deputation shall not exceed 56 (Fifty six) years as on the closing date prescribed for receipt of application.
- 4. Applications of officials who are eligible and are willing to be considered for appointment on deputation basis and who can be relieved immediately after selection may be forwarded through proper channel along with copies of their ACRs/APARs for the preceding five (05) years and Vigilance Clearance Certificate so as to reach the office of the APCCF, Ministry of Environment, Forest and Climate Change, Regional Office, 25, Subhash Road, Dehradun -248001.
- 5. The receipt of complete application form in the prescribed format (Annexure III) for deputation post should reach this office on or before completion of 45 (Forty Five) days from the date of publication of vacancy. Applications received without the recommendation of the parent Office/Department or incomplete applications or applications received after the prescribed date or without ACR/APAR/dossiers/ Vigilance Clearance will not be considered.

The maximum age limit for appointment by deputation (ISTC) shall be not exceeding 56 years as on the closing date of receipt of applications.

Note 4: Where juniors who have completed their qualifying or eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying or eligibility service by more than half of such qualifying or eligibility service or two years, whichever is less, and have successfully completed probation period for promotion to the next higher grade along with their juniors who have completed such qualifying or eligibility service.
