**TRAINING, EMOLUMENTS & PLACEMENT:**

Selected candidates will undergo training for a period of 2 years at any of NTPC sites/stations and will be paid a consolidated stipend of Rs.24,000/- per month. On successful completion of training, these candidates will be absorbed in the open pay scale of Rs. 24,000/-3%- (W7 grade).

**AGE LIMIT:**

Upper Age limit is 30 years (inclusive of 05 Years Relaxation) as on last date of application.

**QUALIFICATION:**

Note: Eligible candidates, who have Full time regular Diploma passed certificate as on the date of application will only be eligible to apply.

**SELECTION PROCESS:**

Eligible candidates will have to undergo 2 stage of Online Test (Computer Based Test).

**1<sup>st</sup> stage online test:** In first stage, Online Aptitude Test (120 multiple questions) covering General English, Quantitative aptitude & Reasoning will be conducted. The duration of the test will be 2 hours. Each question carries 1 mark and 0.25 marks will be deducted for wrong answer. The qualifying marks for this stage is 30%. The candidates will be shortlisted @ 1:10 for 2<sup>nd</sup> stage Online Test (Technical). 1st Stage test is only qualifying in nature and will not have any weightage in the final selection.

**2<sup>nd</sup> stage Online Test:** In 2<sup>nd</sup> stage, Online Technical Test (120 multiple questions) in respective discipline will be conducted. The duration of the test will be 2 hours. Each question carries 1 mark and 0.25 marks will be deducted for wrong answer. The qualifying marks for this stage is 30%. No skill test will be conducted.

Offer of appointment shall be issued based on merit.

#### **TEST CENTERS:**

1. **Bangalore**
2. **Hyderabad (if required, based on the number of applicants).**

#### **RESERVATIONS AND RELAXATIONS:**

- 01 There is no application fee for this post.
- 02 Reservations and relaxations for XSM / PwBD (degree of disability 40% or above) candidates will be provided as per Government guidelines.
- 03 The upper age limit is relaxed by 10 years for PwBD-ST Candidates and Land Oustees of NTPC-Kudgi project who belong to ST Category.
- 04 Upper age is relaxed by 5 years for the candidates who had ordinarily been domiciled in the state of Jammu & Kashmir from 01.01.80 to 31.12.89. Age relaxation will be applicable for XSM as per Government guidelines.
- 05 Category once filled in the online application form will not be changed and no benefit of other category will be admissible later on.

#### **SERVICE AGREEMENT BOND:**

The selected candidates will be required to execute a service agreement bond of Rs 50,000/- (plus GST) for SC/ST/Physically Challenged Person to serve the company for a minimum period of 3 years after completion of training.

#### **HEALTH:**

The candidate should have sound health. Before joining, candidates will have to undergo medical examination by NTPC Medical Board and the decision of the board will be final and binding. Appointment will be subject to meeting the medical norms prescribed by the Company. No relaxation in medical norms is allowed. Detailed medical norms are available on the website.

- 01 Only Indian Nationals are eligible to apply.

- 03 All qualifications should be from Indian Institutes recognized by BTE/AICTE / appropriate statutory authority.

- 04 No manual / paper application will be entertained.
- 05 TA/DA will **not be paid** to any candidate appearing for the the 1st stage and 2nd stage Online Test.
- 06 While applying for the post, the applicant should ensure that he / she fulfills the eligibility and other norms mentioned above, as on the specified dates and that the particulars furnished are correct in all respects. In case it is detected at any stage of recruitment that a candidate does not fulfill the eligibility norms and / or that he / she has furnished any incorrect / false information or has suppressed any material fact(s), his/her candidature will stand automatically cancelled.
