M.Sc. in Botany/Zoology/Forestry/Wildlife/Soil Sciences from a recognized University with 1st Division (at least 60% Marks).

- Field work experience in the field of forestry research with knowledge and experience in identification of tree, shrubs and herbs in the forest and measurement of inventory parameters of forest vegetation.

- Physically fit for extensive travel and trek in the mountainous/ plain region.
- Research Articles published in a recognized journal.


Candidates must submit the application in the format attached along with the following documents.
