West Bengal State Health & Family Welfare Samiti will engage personnel as **State Consultant - Health System Planning & Convergence** under **National Health Mission**, Department of Health and Family Welfare, Government of West Bengal purely on contractual basis.

**The applicant must be a permanent resident of West Bengal.**

**The applicant must have knowledge of local languages.**

Thereafter the qualifying candidates will appear for Computer Test. Qualifying Marks for Computer Test is 50%. Final Selection will be made on the basis of total marks obtained in Academic and Experience score, Written Test, Computer Test and Interview.
