**RECRUITMENT CONDITIONS:**

1. Other service conditions as prescribed from time to time by the Hospital will be applicable.
2. Seats will be reserved for differently abled candidates as per the prevailing Govt. rules.
3. The decision of the Selection Board/Medical Superintendent of AAA Hospital regarding selection will be final and no representation will be entertained in this regard.
4. The appointment and services will be governed under the Residency Scheme. Total tenure of a junior resident will be maximums of one year. Appointment will be initially for a period of 89 days extendable up to maximum of one year on the basis of satisfactory work & conduct report from the concerned HOD and written request from the JR concerned.

6. **All appointment shall be subject to medical fitness and verification of certificate of educational qualification/age/caste/submission of valid DMC registration certificate etc.**

Delhi Medical Council will also be intimated for initiating appropriate action.
