2. ELIGIBILITY CRITERIA FOR THE POST OF SENIOR RESIDENTS

A. Qualification:-

- (1). MBBS with Post Graduate Degree/ DNB/ Diploma or equivalent as per residency scheme in concerned specialty from a recognized University/ Institution.
- (2) If candidates having PG Degree/Diploma (in Medicine) are not available those with PG (Chest/Emergency Medicine/ Geriatric Medicine) may be considered.
- B. Age: Below 45 years, On Date of Interview, as per order No.F.DHF&W/Q015/57/2016-HR-Medical-secy(H&FW)/CDNo.112425062/1502-08 dated 26.11.2020. Age limit is relaxable by 05 year for SC/ST candidates.
- C. Pay:- Basic of RS. 67700/- in pay Matrix 11 of 7th CPC with other allowances as admissible per month.
- D. The candidate must have completed internship.
- E. Must be registered with Delhi Medical Council.
- F. Appointment will be initially for a period of 89 days or till regular joins, whichever is earlier and may be extended beyond 89 days maximum upto 03 years on the same conditions based on work and conduct report.
- G. Appointment will be subject to medical fitness and verification of certificate of educational qualification/age/caste/DMC registration and internship completion certificate etc.
- H. Candidate must not have completed three year senior residency from any Govt.Hospital.(*) (*)Further in case of non-availability of candidates, as per the relevant scheme mentioned above, candidates may be considered in terms of relaxation of provision as per circular No. F.No. 121/26/2010/H&FW/1996-2045, dated 10.06.2011 issued by Health & Family Welfare Department, Govt. of NCT of Delhi with the following relaxation.
 - 1. In the Specialties where no fresh candidates are available, candidates, who have completed 3 years of Sr. Residency, may also be allowed to appear in the interview.
 - 2. Separate merit list would be prepared for the candidates who have completed their residency of 3 years as SR.

- Solution 3. Firstly the list containing name of fresh candidates would be exhausted for appointment as SR and the second would be used only after that.
 - 4. Further, all senior Resident appointment from second list will be for one year only for those who have already completed 3 years of Residency. It would not be renewable after one year. Senior Resident may be assigned duties in Emergency Department as & when required in case of any exigency.
