(A)ELIGIBILITY

(1) Educational Qualifications For the Posts at Sr. No. 1 and 2

<u>Desirable Qualification as per UGC Regulations</u> [Maharashtra Agricultural Universities (Krishi Vidyapeeths) (First Amendment) Statutes, 2014]:

(i) Ph. D. In relevant/ concerned subject as per the post advertised from an Indian University, or an equivalent degree from an accredited foreign university.

OR

Masters degree in relevant discipline from an accredited Indian University, Or an equivalent degree from an accredited foreign university along with National Eligibility Test (NET) conducted by Indian Council of Agriculture Research (ICAR)/ University Grants Commission (UGC)/ Council of Scientific and Industrial Research (CSIR) or similar test accredited by the University Grants Commission (UGC) like State Level Eligibility Test (SLET)/ State Eligibility Test (SET).

(ii) National Eligibility Test (NET)/State Level Eligibility Test (SLET)/State Eligibility Test (SET) shall also not be required for such Masters Programme in disciplines for which NET/SET is not conducted. However, Ph, D. degree shall remain the minimum eligibility for appointment of Assistant Professor in such disciplines.

(B) Work Experience:

The candidate with relevant work experience as per the nature of post will be given preference.

(C) Nature of Work:

The selected candidate has to conduct UG courses along with related academic work such as conducting mid-term and semester end practical examinations, setting of question and model answer papers, evaluation of answer paper, preparation of results, maintaining records of student attendance and assisting in student co-curricular activities etc., as per the guidelines of Associate Dean, Ccollege of Horticulture, Mulde.

(D) AGE LIMIT:

Candidates should not exceed 38 years on the last date of submission of application expect backward class candidates which is relax able by 5 years.

(E) Procedure for Application:

- i. Applicants satisfying the above eligibility shall submit their hard copy of the application to **Associate Dean, College of Horticulture, Mulde** covering all the points in the prescribed proforma enclosed herewith for application on plain A-4 size paper only.
- ii. The complete application in all manner should reach to office address "Associate Dean, College of Horticulture, Mulde, Tal. Kudal, Dist. Sindhudurg, Pin 416 520, State-Maharashtra". In person or by post/ courier on or before date 10-01-2023(during office hours). The applications received thereafter shall not be considered.
- iii. All the necessary photocopies of documents/certificate like age, educational qualifications, date of birth, caste, experience etc. as indicated in the advertisement should be attached with the application and it must be duly attested by competent authority/self attested.
- iv. The candidate has to submit 'No objection Certificate' with an application form of present employer in case if he/she is already in service.
- v. The envelope of the application should be superscribed as "Application for the post of" (Mention Sr. No, Name of contractual post as per advertisement).
- Vi. The University authorities reserve the right of rejection of any application form due to non- observance of these instructions.

(F) Short-listing Criteria:

- i. The eligible candidates for the posts will be short-listed by the Scrutiny Committee appointed by the University as per their high merit of educational qualification, research methodology, contribution towards institutional building and experience under the rules prescribed by the University, viz. "Rules for evaluation of the candidates applied for the posts of Assistant Professor & it's equivalent on the Establishment of the College of Horticulture, Mulde.
- ii. Mere eligibility does not vest any right to the candidates of being called for the interview. The College reserves its right to call or not to call for the interview.

(G) Interview Schedule:

- i. The date and time of interview will be communicated to the shortlisted eligible candidates through e-mail or telephone.
- ii. The eligible candidates should appear for the interview in the Office of Dean & Director of Instruction, Dr. Balasaheb Sawant Konkan Krishi Vidyapeeth, Dapoli, Dist. Ratnagiri, Pin 416 520, State Maharshtra along with the original documents and bio-data.
- iii. The candidate has to appear for interview, at his/her own cost. No TA/DA will be paid to the candidate appearing for interview.
- iv) The university/college authorities have kept all rights to change or cancellation of interviews, if any.

(H) Procedure for Selection:

- i. All the application received in response to the vacancies advertised by rolling advertisement of this office, will be scrutinized, and shortlisted for selecting the eligible candidates for engagement as Assistant Professor by the screening committee constituted by the university.
- ii. The shortlisted candidates have to appear before the screening committee for an interview as per the earmarked date intimated by this office.

(I) Office Timings and Working Hours:

i. Working Hours of selected candidate shall coincide to working hours of regular employees of this office i.e. from 9.00 AM to 5.30 PM, including half an hour lunch from 1.30 PM to 2.00 PM, during working days.

- ii. In exigencies of work, candidate may be required to sit late and attend to work on Saturday/Sunday and other Gazette Holidays.
- iii. Candidate will mark their attendance on Adhar Based Biometric Attendance System/Attendance Register maintained by this office depending on situation.

(J) Terms and Conditions of the Engagement

- 1. The appointment is purely on temporary basis for the period of **eleven months** for the Assistant Professors.
- 2. The selected candidate's performance will be evaluated by the Associate Dean, College of Horticulture, Mulde. If the assigned work and conduct of the candidate is not found satisfactory during his/her tenure of appointment, his/her service will be terminated even before completion of the term for which he/she is appointed.
- 3. The undersigned reserves the right to reject one or all the applications at his discretion without any reason thereof.
- 4. The selected candidates will be required to give an undertaking on stamp paper worth Rs. 100/-, that he/she will not leave job during the appointment period and shall complete the assignment within prescribed limit.
- 5. The selected candidate has to join under Associate Dean, College of Horticulture, Mulde
- 6. The university authorities reserve the right not to fill up the post even after selection of the candidate.
- 7. The candidate should not claim for his/her continuation of service as well as claim for appointment on regular establishment in the service of Dr. Balasaheb Sawant Konkan Krishi Vidyapeeth, Dapoli.
- 8. Pursuant to the decision of the Supreme Court vide petition no SLP-5453/90, candidate on this appointment will not be eligible for permanent employment in university service.
- 9. The services of the appointed candidates can be discontinued at any time without giving any prior notice, on administrative grounds.
- 10. Candidate availing age benefit will need to attach non-cream layer & caste certificate.
- 11. As this scheme is education oriented and continuous in nature, the selected candidate should render their services with due responsibility and give the result of the scheme as well as all other information as per the requirement of scheme to the concerned office and as per directives from the university.
- 12. The candidate has to appear for interview, at his/her own cost. No TA/DA will be paid to the candidate appearing for interview.
- 13. The candidate will have to give one month's advance notice if he/she desire to leave the job failing which he/she will have to surrender one month salary.
