Applications are invited in the prescribed format for the post of "Project Technical Support III" in the research project funded by Indian Council of Medical Research (ICMR) project entitled "Development of a Loop-Mediated Isothermal Amplification (LAMP) assay for on-site diagnosis of Trichomonas vaginalis, Chlamydia trachomatis, and Neisseria gonorrhoeae from patients attending STI clinic; Proposal Id: 2022-17644" in the Department of Microbiology under Dr. Rudresh SM (Principal Investigator) Associate Professor. The post is purely on temporary basis for a maximum tenure period of 30 months at the ESIC MC PGMSR & MH, Rajajinagar, Bengaluru-10.

Medical Microbiology and Molecular Biology curriculum. The marks obtained in the screening test will not in any way be linked to the final selection process. The performance of the candidate in the interview will be the sole criteria for selecting the candidate for the respective post. Mere participation in the screening test will not confer any claim for the post.

No benefit of Provident fund, Hostel accommodation, Leave Travel Concession, Medical Claim etc. will be considered, since the post is purely on contract basis.
4. No enquiries shall be entertained in this regard after due date.
5. Candidate should bring duly filled form, self-attested photocopies, eligibility

qualification mark sheets, degrees, experience certificate, qualifying degree registration with statutory council (if applicable) and other relevant testimonials at the time of interview.

6. All educational professional and technical qualification should be from a recognized Board/ University and full-time.
7. The experience requirement specified should be experience acquired after obtaining the minimum educational qualifications required for the post.
8. Age / Education qualification / Experience will be considered till last date of the advertisement.
9. Candidates who fail to bring the original certificates at the time of joining and if any discrepancy is found in the documents such candidates will not be allowed to join the selected contract post and the position will be offered to the waiting list candidates.
