(ii) Only such candidates will be called for Viva-voce as the High Court may decide on the basis of merit of their performance in the written examination. Provided that a candidate appearing in the written examination for selection by direct recruitment from amongst the eligible advocates must secure 50% or more mark in the written Examination. The maximum number of candidates who are to appear in the interview/Viva-voce will be in the ratio of 3:1 of total number of vacant post. Knowledge of Manipur State Official Language will be tested during the Viva-voce. (iii) The Viva-voce shall carry a maximum of 50 marks and candidate should secure at least 40% marks for inclusion in the select list. (iv) The selection of the candidate would be subject to the outcome of the Writ Petition (C) No. 294 of 2015 pending in the Hon'ble Supreme Court of India. (v) A candidate selected for appointment shall be required to undergo medical examination of physical fitness by a Medical Board before he/she is appointed. Every candidate who appears before medical board shall pay the Medical Examination fee which, in no case, is refundable.

Manipur Judicial Service Grade - I Recruitment Examination consists of 3 (three) papers of 3 (three) hours duration each.

The competitive Examination shall be conducted with the syllabus as given below:-

- (i) <u>General Awareness and English</u> One paper of 100 marks for a duration of 3 (three) hours to test the General Knowledge, Aptitude, Intelligence, Test of Comprehension and Expression of Law and General English including Essay Writing on Legal Topic and Information Technology.
- (ii) <u>Law Paper I</u>: One paper of 100 marks for a duration of 3 (three) hours regarding objective questions and problems of law as regards the Transfer of Property Act, Civil Procedure Code, Code of Criminal Procedure, Indian Evidence Act, Indian Penal Code, Limitation Act
- (iii) <u>Law Paper II</u>: One paper of 100 marks for a duration of 3 (three) hours consisting of Judgment Writing (Paper Book to be supplied) – Legal Theories on Jurisprudence, Provision of Constitution of India.

Note: (The candidate is expected to refer to the relevant decisions of the Apex Court and the High Courts while writing answers in Law Paper I and II)

- 7. The date of Examination(s). Centre of Examination will be indicated only in the Admit Card.
- 8. Applicants in Government service other than casual or muster roll will be required to state in the Application Form that they have informed in writing their employer/controlling authority that they are applying for the examination. In case the employer or the controlling authority withholds permission to the candidate for appearing in the examination, such applications will be rejected.
- 9. If any candidate is found indulging in any irregularity/misconduct/malpractice at any stage of recruitment, the candidate shall be debarred for a period as fixed by the High Court of Manipur, apart from cancellation of candidature for the examination without prejudice to any other legal action. The High Court may take appropriate action as deemed fit including verification of Signature, Thumb Impression, Handwriting, and Photograph etc. captured during various stages of recruitment to ascertain genuineness of candidates to ensure fair selection.
- 10. Candidates must carry at least one photo bearing IDENTITY PROOF in original such as Driving Licence, Voter ID Card, Aadhaar Card, Identity Card issued by University/College, Income Tax PAN Card to the examination centre, failing which THEY SHALL NOT BE ALLOWED TO APPEAR FOR THE EXAMINATION.
- 11. Mobile Phones or any of the IT Gadgets are not allowed inside the premises where the examination is being conducted. Any infringements of these instructions shall entail disciplinary action including ban from future examinations.
