	produce NO OBJECTION CERTIFICATE from the employer at the time of interview
2	Pay certificate duly signed by the pay drawing authority should be attached along with
	details of experience and present status.
3	Mere fulfillment of the qualifications prescribed does not entitle the candidate to be called for
	interview.
4	In case of large number of applications, the Institute may shortlist the candidates as may be
	necessary.
5	Only Indian Nationals are eligible to apply.
6	No correspondence will be entertained from the candidates regarding postal delays, short-
	listing, reasons for not being called for interview, selection or appointment.
7	Experience will be reckoned as on the last date of submission of application. Clear quality
	Xerox attested copies of all important certificates and documents must be uploaded with the
	online application.
8	The prescribed requirements are minimum and the mere fact that a candidate possesses
	the same will not entitle him / her for being called for interview. Applicants having higher
	qualification and merit will be givenpreference.
9	Institute reserves the right not to fill up any of the vacancies advertised, if the circumstances
	so warrant. The Institute reserves the rights to withdraw the advertised post(s) at any time

	without giving any reason. Any consequential vacancies arising at the time of interview may
	also be filled up from the available candidates. The number of positions is thus open to
