Regional Institute of Ophthalmology, Kolkata will engage personnel for the position of Counsellors for the Kolkata based Medical College &Hospitals of West Bengal on contract basis in National Program for Control of Blindness & Visual Impairment (NPCB&VI) under National Health Mission. The applicant must be the permanent residence of West Bengal.

Eligible candidates should <u>apply</u> in the prescribed format as given in the Department's website (<u>www.wbhealth.gov.in</u> and <u>www.riokolkata.in</u>) alongwith self-attested photocopies of all testimonials. Application for the mentioned position should reach on or before 4 PM of 02.01.2024 (Tuesday) for the above mentioned position. Application forms not properly filled in or incomplete application forms are liable to be cancelled.

Application fees of `Rs. 100/ for Unreserved category candidates and `Rs. 50/- for Reserved category candidates (SC, ST) have to be deposited through <u>a bank draft in favour of</u> Regional Institute of Ophthalmology payable at Service Branch, Kolkata.
