2. ELIGIBILITY CRITERIA FOR THE POST OF SENIOR RESIDENTS

A. Qualification:-

- (1). MBBS with Post Graduate Degree/ DNB/ Diploma or equivalent as per residency scheme in concerned specialty from a recognized University/ Institution
- B. Age: Below 45 years, On Date of Interview, as per order No F.DHF&W/Q015/57/2016
 HR-Medical-secy(H&FW)/CDNo.112425062/1502-08 dated 26.11.2020 Age limit is relaxable by 05 year for SC/ST candidates.
- C. Pay:- Basic of RS. 67700/- in pay Matrix 11 of 7th CPC with other allowances as admissible per month.
- D. The candidate must have completed internship.
- E. Must be registered with Delhi Medical Council.
- F. Appointment will be initially for a period of 89 days or till regular joins, whichever is earlier and may be extended beyond 89 days maximum upto 03 years on the same conditions based on work and conduct report.
- G. Appointment will be subject to medical fitness and verification of certificate of educational qualification/age/caste/DMC registration and internship completion certificate etc.
