(Holders of educational qualifications included in Part II of the Third Schedule should also fulfill the conditions stipulated in Section 13 (3) of the said Act); and</p> <p>(ii) A post graduate qualification equivalent to MD (Doctor of Medicine) or MS (Master of Surgery) or a recognized qualification equivalent thereto in the respective subject/allied discipline and above.</p> <p><b>Experience :</b></p> <p>Eight years of work experience in the concerned specialty after obtaining the PG Degree.</p> <p><b>Scope of work:</b> Each visiting faculty will be required to conduct one session of 3 hours duration.</p> <p>The Visiting Faculty shall not be involved in the routine administrative work of the department and shall not replace the roles and responsibilities of the full-time faculty in the department.</p> <p><b>NOTE (1)</b> The experience should be recognized by the Medical Council of India or the statutory body concerned with the system of medicine as valid teaching experience for teaching posts and certificate thereof or any other valid proof in support thereof should be submitted and a certificate to this effect is to be submitted.</p> <p><b>NOTE (2)</b> Teaching experience in any other post like the most of General Duty Medical Officer shall not be considered for eligibility purpose for recruitment to teaching posts.</p>

**B. TERMS OF CONTRACT**

- iii. Other terms and condition will be applicable as issued by competent authority from time to time.
