VACANCY CIRCULAR

It is proposed to fill up three (03) vacancies of Staff Car Driver (Ordinary Grade) (General Central Service, Group C, Non-Gazetted, Non-Ministerial) in Level-2 of pay matrix (Rs.19900-63200) in the office of UPSC on Deputation or Absorption or Re-employment basis.

2. <u>Eligibility Conditions</u>:

A. Deputation or Absorption:-

From amongst the regular Despatch Rider and Multi Tasking Staff working in the office of the Union Public Service Commission who fulfill the qualification as mentioned for direct recruits which are as under:-

- i. Possession of valid driving license for motor cars;
- ii. Knowledge of motor mechanism (the candidates should be able to remove minor defects in vehicle);
- iii. Experience of driving a motor car for at least three years; and
- iv. 10th standard pass

failing which from officials holding the post of Despatch Rider on regular basis or regular Multi Tasking Staff or equivalent in other Ministries of the Central Government who fulfill the qualifications as mentioned for direct recruits.

For Armed Forces Personnel:-

B. Deputation or Re-employment:-

The Armed forces Personnel who are due to retire or to be transferred to reserve within a period of one year and possessing qualifications and experience as mentioned under:-

- i. Possession of valid driving license for motor cars;
- ii. Knowledge of motor mechanism (the candidates should be able to remove minor defects in vehicle);
- iii. Experience of driving a motor car for at least three years; and
- iv. 10th standard pass

shall also be considered and if selected, such officers shall be given deputation terms upto the date on which they are due for release from the Armed Forces and thereafter, they may be continued on re-employment terms.

Note 1: The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or other organisations or departments of the Central Government shall not exceed three years.

Note 2: The maximum age-limit for appointment by deputation shall not be exceeding fifty-six years as on the closing date of receipt of applications.

3. Regulation of pay and other terms of deputation:

The pay of the selected candidate will be regulated under the provisions contained in the DoP&T O.M. No. 6/8/2009-Estt.(Pay-II) dated 17.06.2010 as amended from time to time.

4. <u>Age-limit</u>:

The maximum age limit for appointment on deputation basis shall not exceed fifty-six years as on the closing date of receipt of application

5. Period of deputation:

Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation/Department of Central Government shall not ordinarily exceed three years.

- **6.** Application (in duplicate) only in the prescribed proforma (Annexure-I) of the eligible candidates whose services can be spared immediately on selection, together with the certificate from the Forwarding Authority (in proforma Annexure-II) along with the following documents: -
 - (i) Integrity certificate
 - (ii) List of major/minor penalties imposed if any, on the official during the last 10 years; (if no penalty has been imposed a 'Nil' certificate should be enclosed).
 - (iii) Vigilance clearance certificate.
 - (iv) Attested photocopies of APARs for the last five years (2018-19 to 2022-23) (attested on each page by an officer not below the rank of an Under Secretary to the Government of India).


