Applications are invited in a closed cover for the post of Typist-cum-Assistant on Out Sourcing basis initially for a period of one year from the date of joining in MLSC within the jurisdiction of DLSA., Vizianagaram covered under A.P. State Legal Services Authority Services Rules, 1999 r/w. A.P. State & Subordinate Services Rules carrying Remuneration - Rs.18,500/- (Rupees Eighteen Thousand Five Hundred only only) per month. I. EDUCATIONAL QUALIFICATIONS :

The applicant must possess Graduation from a recognized University in India and has passed the Government Technical Examination in Typewriting by Higher Grade in English and if such persons are not available, passing Government Technical Examination in Typewriting by Lower Grade in English will be considered, as per Rule 6 (2)(g) of A.P. State Legal Service Authority Service Rules, 1999. The applicants who possess technical qualifications like computers, shorthand in English etc., will be given preference.

II. LINGUISTIC QUALIFICATION:

The applicant must possess an adequate knowledge of Telugu and English.

III. AGE LIMIT :

The applicant must have completed 18 years and must not have completed 42 years as per G.O. Ms.No.109, General Administration (SER.A) Dept., 10-10-2023, r/w. Rule 6 (c) of the A.P. State Legal Services Authority Service Rules, 1999.

Provided that the upper age limit of 42 years is relaxable by 5 years in respect of the persons under Scheduled Castes/Scheduled Tribes/Backward Classes and EWS.

Provided that the upper age limit of 42 years is relaxable by 10 years in respect of physically disabled persons.

Provided that the upper age limit of 42 years is relaxable for Ex-Servicemen as per Rule 12 (1) (c) (i) of A.P. State and Subordinate Service Rules, 1996.

IV.METHOD OF RECRUITMENT :

1. A Written Exam/Skill Test and interview will be conducted depending upon the number of applications received and as per the directions of the Principal District Judge-cum-Chairman, District Legal Services Authority, vizianagaram.
2. The decision of the Principal District Judge-cum-Chairman, District Legal Services Authority, Vizianagaram shall be final with regard to the recruitment process.
3. Merely attending and securing minimum qualifying marks will not vest any applicant with a right to be considered for the selection.
4. No person shall be eligible for appointment unless he/she satisfies the following conditions :
 - vii) That he/she is of sound health, active habits and free from any bodily defects or infirmities rendering him/her unfit for the appointment.
 - viii) That his/her character is such as to qualify him/her for such service.
 - ix) He/she must be citizen of India.

VI.GENERAL INSTRUCTIONS :

1. The applicants shall indicate their local/non local status in the application.
2. Merely applying for a post will not give any right to any person to be considered for appointment.
3. A person in a bigamous marriage shall not eligible for appointment.
4. No woman whose marriage is void by reason of the husband having a wife living at the time of such marriage or who has married a person who has a wife living at the time of such marriage, shall be eligible for appointment.
5. No person, who has been dismissed from a State or Central Government service or from the service of undertaking of Central or State Government or local or other Authorities shall be eligible for appointment.
6. No person, who has been convicted by a Court of Law for an offence involving moral turpitude, shall be eligible for appointment.
7. No TA and DA will be paid to the candidates who appear for written test/Skill Test and Interview.

8. Candidates resorting to or bringing any influence of any kind will be summarily disqualified and they are liable for prosecution as per Law.
9. The particulars furnished by the applicant in the application form will be taken as final. Candidates should, therefore, be very careful in filling the application.
10. Correspondence will not be entertained by this Authority under any circumstances. Incomplete/incorrect application will summarily be rejected at any stage.
11. If suppression of information/furnishing of false information is noticed, either in the application or in the enclosures, at any stage before the final selection, the application of the candidate will summarily be rejected. In addition, the candidate will also be liable for appropriate action/prosecution as per Law.
12. No information will be sent to the unsuccessful candidates after announcement of list of qualifying candidates in the written test and interview.
13. The applications with incomplete data, without photographs, without required enclosures, without self addressed cover with postal stamps, without signature in the application form will summarily be rejected.
14. The applications received after due date will summarily be rejected.
15. The candidate shall submit valid proof of photo identity at the time of exam/skill test/interview.
16. The candidates shall attend the venue one hour before the exam/skill test/interview for verification of original certificates.
17. The candidates shall submit attested copies of required documents/certificates along with application on or before the due date.
18. The decision of the Principal District Judge-cum-Chairman, District Legal Services Authority, Vizianagaram is final in respect of written test/skill test and or interview for the candidates.
19. The decision of the Principal District Judge-cum-Chairman, District Legal Services Authority, Vizianagaram is final in case of ambiguity arises.
