01. The experience certificate must contain the period with date, name of the posts held and nature of work done etc.
02. The selection of the candidates will be based on written examination and Physical Endurance Test (PET) (Swimming test) as applicable to the post and also subject to Medical fitness.
03. Photograph pasted on the application shall be duly signed.
04. No. T.A. will be paid for the Written test/ PET test.
05. Candidates with higher qualification may also apply.
06. Serving Government candidates should apply through proper channel with a certificate from the Head of Department that no disciplinary/vigilance case is pending against them.
07. Canvassing in any form will be a disqualification and candidature of such candidates is liable to be summarily rejected.
08. There is no Application Fee.

09. The Department reserves its right to accept or reject the candidature of any applicant and/or to cancel the recruitment at any stage without assigning any reason whatsoever.

This office shall not be responsible for any postal delays.

17. The Last date for submission of online application form is 25.03.2024 and the last date for receiving of print out of application form along with all the relevant documents in this office is 04.04.2023 (18.15 Hrs.)
18. Incomplete or unsigned application and applications received without photograph or without proper enclosures or received late will be summarily rejected.
19. Mere online submission of application will not confer any right on the applicant to be called for written test.
20. Candidates are advised in their own interest to submit online applications much before the closing date and not to wait till the last date to avoid the possibility of disconnection/inability or failure to login to the website on account of heavy load on the website during the closing days.
