Note:

1. A person who retired in the Last Grade Service in the Subordinate Courts and in the Hon'ble High Court is eligible for appointment to the post of Attender (on contract basis).
2. The ministerial Staff who retired on attaining the age of superannuation and who have not attained the age of **sixty five** years are eligible.
3. A person who has received any punishment for any misconduct in disciplinary proceedings while in service is not eligible for appointment to the post of Attender(on contract basis)
- 4.The employees who were dismissed, removed, compulsorily retired or made to seek retirement are not eligible for re-employment.
5. A person of unsound mind or is deaf or mute or blind or suffering from leprosy or any other contagious deceases is not eligible for appointment to the post of Attender(on contract basis).
6. Preference will be given to the local candidates i.e., persons worked and retired in Visakhapatnam District Judiciary. If there are no suitable persons in the District, the appointing authority may take candidates from the other districts also.
7. Persons selected, has to produce a physical fitness certificate.
8. The candidates shall be required to discharge their duties sincerely, courteously and honestly to the satisfaction of the Presiding Officers.
9. The services of the candidates are liable to be terminated at any time without assigning any reasons and without any notice and the appointment is purely temporary and on ad-hoc basis.
10. On appointment, the appointees shall enter into an agreement with the District Judge upto 31.03.2026, subject to renewal for further period from time to time at the discretion of the Hon'ble High Court.

11. This Notification for appointment to the post of clerk-cum-Typist (on contract basis) is issued subject to the orders to be issued by the Government and Hon'ble High court for extension of contract services of the employees.
